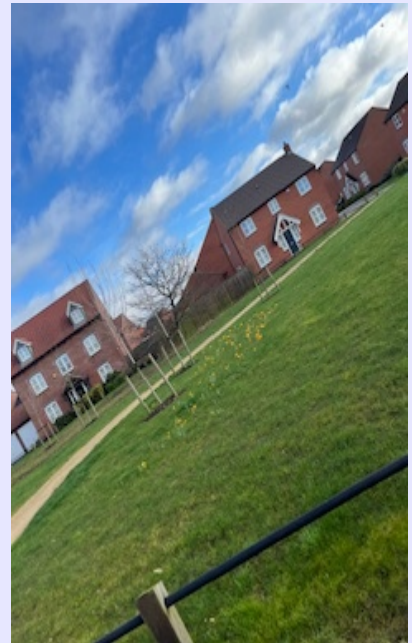

Infrastructure Funding Statement 2023/24

Under the **Community Infrastructure Levy (Amendment) (England) (No.2) Regulations 2019**, all authorities have a duty to prepare and publish an **Infrastructure Funding Statement** if they issue a Community Infrastructure Levy (CIL) notice or receive money or in-kind works from a Section 106 agreement. This Statement is prepared by the Borough Council to provide an overview of financial developer contributions and non-financial contributions that the Borough Council has secured, received and spent relating to S106 Legal Agreements during the financial period of 1st April 2023 and 31st March 2024.

S106 Agreements (S106)

S106 is a legal document of obligations entered into under Section 106 of the Town & County Planning Act 1990 (as amended) by the Local Planning Authority (LPA) to seek obligations both physically on site and contributions off site, when it is considered that a development will have a negative impact that cannot be dealt with through conditions contained within a planning permission.

The obligations may be provided by the developers “in kind” – that is, where the developer builds or directly provides the matters necessary to fulfil the obligation. This might be to build a certain number of affordable homes on-site. Alternatively, planning obligations can be met in the form of financial payments to the Council to provide off-site infrastructure works or contributions towards providing affordable housing elsewhere in the Borough. In some cases, it can be a combination of both on-site provision and off-site financial contributions.

The Government states that a planning obligation may only constitute a reason for granting planning permission for the development if it is:

1. **Necessary to make the development acceptable in planning terms;**
2. **Directly related to the development; and**
3. **Fairly and reasonably related in scale and kind to the development.**

Where it is determined that on-site infrastructure and/or affordable housing required by policy is not appropriate, the Council will request from developers a financial contribution to meet the needs outside of the development site through a s106 obligation.

The financial contribution requirement for off-site green infrastructure provision is set via Hinckley and Bosworth Borough Council’s [Open Space and Recreational Facilities Study \(2016\)](#), and off-site affordable housing contribution requirements are set by the [Affordable Housing SPD](#).

Financial contributions towards infrastructure because of a new development is agreed on a case-by-case basis and these contributions are usually requested to mitigate any negative impacts the new development would create.

Planning obligations towards the Leicester, Leicestershire, and Rutland Integrated Care Board (NHS), Leicestershire Police & Crime Commissioner, the Canal and River Trust and the National Forest for new developments are agreed on a case-by-case basis.

Once the s106 has been signed and planning permission issued, it becomes an obligation, but it will only be realised if the planning permission is implemented, the development is commenced and the trigger points for payment as set out in the s106 agreement are reached.

Leicestershire County Council planning obligations such as education, highways and transportation, library and household waste recycling centres and waste management are all collected and spent by the County Council, and it is their responsibility to report on their own contributions separately. Leicestershire County Council’s IFS are available to view on their website by 31st December of each reporting year:

Annual Infrastructure Funding Statement

Each year the report is published (by 31st December of the reporting year) on the Councils Website, where it is readily available to members of the public and any interested parties.

The detail set out in each table below is based on the requirements set out in Regulation 121a, Schedule 2, Section 3 (a) – (i) of the Community Infrastructure Levy Regulations (Amendment) (2019)¹

In the Infrastructure Funding Statement reference will be made to the following definitions:

- **Secured** – contributions which have been secured in a signed and sealed legal agreement. The contributions will not yet have been received by the Council and if the planning permission is not implemented then there would be no requirement for the contributions.
- **Received** – financial or non-financial contributions which have been received by the Council.
- **Allocated** – contributions which have been received by the Council and allocated to specific projects.
- **Spent/delivered** – financial or non-financial contributions which have been spent or delivered.
