

## **Dadlington Neighbourhood Plan**

# Notice of Regulation 15 Submission and Regulation 16 Consultation Guidance Notes

#### Overview

Dadlington Neighbourhood Plan group commenced the neighbourhood plan work covering a Dadlington-specific area of Sutton Cheney Parish in 2019. The area is identified in maps available in the supporting documentation. The notice of Regulation 15 Submission, and the process of proceeding to Regulation 16 Submission Consultation is as follows.

Sutton Cheney Parish Council is a qualifying body as prescribed by Section 61F of the Localism Act 2011.

The Dadlington Neighbourhood Plan is the only such document relevant to the designated plan area and is therefore not considered a repeat proposal for the purposes of Schedule 10, paragraph 5 of the Localism Act 2011.

The Dadlington Neighbourhood Plan proposal does not include any development that would be defined as 'excluded development' as prescribed by Schedule 9, Section 61k of the Localism Act.

The submission of the Dadlington Neighbourhood Plan proposal to Hinckley and Bosworth Borough Council during January 2025 included the following items;

- a) the Consultation Statement;
- b) the Dadlington Neighbourhood Plan;
- c) the Basic Conditions Statement;
- d) a map/statement (in this case within the Basic Conditions Statement) identifying the area to which the plan relates;
- e) Minutes of the Sutton Cheney Parish Council Meeting on 14 November 2025 which approved the submission;
- f) The SEA Screening Statement, dated January 2023, which confirmed the Neighbourhood Plan was not subject to a full SEA or HRA; and
- g) Other related supporting documents and evidence base documents.

The above documents are considered to adequately fulfil the submission requirements under Regulation 15 of the Neighbourhood Planning (General) Regulations 2012 and Schedule 4b of the Town and Country Planning Act 1990, as inserted into Schedule 10 of the Localism Act 2011.

Hinckley and Bosworth Borough Council are satisfied that the qualifying body of Sutton Cheney Parish Council has satisfied the relevant regulatory requirements to advance the Dadlington Neighbourhood Plan to the Publicity and Consultation Stage (Regulation 16) and subsequent submission of the Neighbourhood Plan proposal for examination.

Hinckley and Bosworth Borough Council will undertake the Regulation 16 Publicity consultation and will invite representations from all those previously consulted through the pre-submission consultation stage (Regulation 14) and any others as prescribed by regulation.
